<i>Committing</i>	Expulsion, Permanent Dean’s Star

<i>Forging Grade</i>	Expulsion, Permanent Dean’s Star
<i>Prior Knowledge of Exact Contents of a Test, Final or Midterm through stealing, Seizure, Purchase, etc.</i>	Expulsion, Permanent Dean’s Star

1. Unless otherwise noted, Removable Deans Star can be removed pending satisfactory completion of the online ethics course.
2. The recommended penalty for any Second Violation is expulsion.
3. Penalties are assigned on a case-by-case basis. Aggravating and mitigating factors will be considered in the rendering of the final penalty
